These patterns contain inherent characteristics which may result in pattern run off and/or pattern appearance variations at the seams or tile edges (darker or lighter pattern lines). These characteristics are inherent in the patterns and are not manufacturing defects. Consideration to these characteristics should be given when selecting an installation method.

All carpet tiles and planks must be installed in accordance with AS2455 Parts 1 & 2 (latest version) and the GH Commercial Carpet Tile/Plank Installation Instructions.

Chair pads are recommended under office chairs with roller castors to preserve appearance retention, act as a deterrent toward delamination and to prevent premature or accelerated wear. Walk-off tiles from the Tuff Stuff II Collection are recommended at entryways to reduce soiling.

Specifications and colourations are subject to manufacturing tolerances. As part of the GH Commercial continuous improvement program, specifications may be changed or colours deleted without notice. For current and complete specifications please visit ghcommercial.com
